



## Communication and Event Intern

### Summary

The Communication and Event Intern will support the Communications Team in the development of the communication and dissemination activities of CO<sub>2</sub> Value Europe. She/He will be supervised by the Communication Team and report to the Director of Communications.

### Main Responsibilities

- Support the Communication Team in the implementation of the communication and dissemination strategy and plan of CO<sub>2</sub> Value Europe.
- Contribute to the organisation of events and the development of communication campaigns at EU, national and international level.
- Create visual contents (infographics, banners, presentations) and videos to increase the visibility of CO<sub>2</sub> Value Europe and Carbon Capture and Utilisation (CCU).
- Support in the creation of contents for the association's bi-monthly newsletters.
- Post content on the CO<sub>2</sub> Value Europe website in WordPress system, and seek ways to enhance the audience experience.
- Contribute to social media activities via Twitter, LinkedIn, and other platforms.

### Profile

#### Job requirements:

- University degree in Communication and Media, Public Relations, Journalism or Social Sciences.
- Fluent in written and spoken English.
- Graphic design and video making skills.
- Ability to translate technical information into accessible communications.
- Robust IT skills, not limited to MS Office.
- Strong interest in climate change, sustainability and energy transition issues.
- Keen eye for detail and ability to prioritise.
- Proactive, organised, enthusiastic, team worker.

#### Desirable criteria:

- Knowledge of any other European languages.



### Contract and location:

Fulltime internship (under the Belgian law, “*Contrat d’Immersion Professionnelle*”) of 6 months with a possibility to extend it, starting from November/December 2022.

The internship is paid and based in Brussels, but may entail some business travels within Europe. Flexibility in working time and place is required.

Clearance to work in the EU without further formalities is a pre-requisite.

CO<sub>2</sub> Value Europe (CVE) is an international and non-profit association founded in November 2017 building on the results and the enthusiasm generated by the EU FP7-funded project SCOT (Smart CO<sub>2</sub> Transformation). Within a few years, CVE has become the legitimate representative of the Carbon Capture & Utilisation (CCU) community in Europe. The association attracted over 70 pioneer members covering the entire CO<sub>2</sub> value chain (incl. industries, research organisation and universities, start-ups and regional clusters), and developed a vast network of many more organisations and individuals who share the belief that CCU technologies are necessary to help the EU reach climate targets, especially for the hard-to-abate sectors.
